This matter came on for a conditional release hearing on the 7th day of February, 2012; present were the Assistant Prosecutor on behalf of the State of Ohio, the defendant, [REDACTED] in person and represented by counsel for defendant, Jeffrey Whitacre.

The Court acknowledged receipt of the ODMH - HCR-20 Risk Assessment Form from Northwest Ohio Psychiatric Hospital concerning conditional release for the defendant dated November 15, 2011. The Court also acknowledged receipt of the conditional release plan submitted by the treatment team at Northwest Ohio Psychiatric Hospital dated December 21, 2011.

The Court adopted the ODMH - HCR-20 Risk Assessment Form from Northwest Ohio Psychiatric Hospital dated November 15, 2011 and conditional release plan submitted by the treatment team at Northwest Ohio Psychiatric Hospital dated December 21, 2011 as part of the record and copies were provided to the Assistant Prosecuting Attorney and counsel for defendant.

The State objected to defendant's placement on conditional release. The State moved for a formal psychiatric forensic assessment to represent defendant's qualifications for conditional release.

**IT IS THEREFORE ORDERED** that defendant shall remain at Northwest Ohio Psychiatric Hospital, Toledo Campus, the least restrictive commitment alternative available consistent with public safety and treatment goals.


**IT IS FURTHER ORDERED** that defendant shall be referred for a formal psychiatric forensic assessment by Northwest Ohio Psychiatric Hospital to determine any qualifications for conditional release. Further, the forensic report shall be submitted to the Court in accordance with O.R.C. §2945.38(E). This Order shall remain in effect unless superseded by further Order of this Court. The defendant shall not be released or discharged from the Northwest Ohio Psychiatric Hospital, Toledo Campus until authorized by further Order of this Court.

**IT IS FURTHER ORDERED** that defendant shall not be permitted to visit group homes and shall follow any conditions as previously set forth by Northwest Ohio Psychiatric Hospital until further Order of this Court.

**IT IS FURTHER ORDERED** that the Sheriff shall transport the defendant to the Northwest Ohio Psychiatric Hospital at Toledo, Ohio for purposes of commitment.
